

TERMS AND CONDITIONS OF USE

EUROPEAN BOARD OF RADIOLOGY, S.L. informs you that the access and use of its online platform "Educational Resources", hosted at www.myebr.org and accessible by means of its URL or through the mobile application "EDiR European Diploma in Radiology" hosted at www.myebr.org (hereinafter, the "**Platform**"), through which you have accessed as an user is commercial and subject to these conditions of access and use, so we recommend that you read them carefully.

Our terms and conditions of use are intended to regulate access and use of this Platform, which from THE EUROPEAN BOARD OF RADIOLOGY, S.L. we make available to the public in an accessible, permanent and free way. Any third party who has access to and uses this Platform shall be considered a user and fully accepts each and every one of the conditions incorporated in these Terms and Conditions and in the Privacy Policy, if any.

The User acknowledges and accepts that he/she has read and understood the Terms and Conditions of Use of the Platform, the contents of which constitute the entire agreement between the User and EBR. By using any of the functionalities of our Platform, the User expressly acknowledges and agrees to be bound by the Terms and Conditions of Use as well as the Privacy Policy of the Platform and other applicable corporate policies of EBR. The refusal to accept these terms and conditions prevents the user from using this Platform.

The owner of the Platform may offer services or products whose particular conditions are specifically informed to the user on a case-by-case basis.

1. Ownership and purpose of the Platform

The Platform is a computer platform owned by EUROPEAN BOARD OF RADIOLOGY, S.L., a company legally constituted under Spanish law with N.I.F. B-62256581, with address at Paseo de Gracia, 86, Planta 8, 08008 Barcelona (Spain) and registered in the Mercantile Registry of Barcelona in Volume 42942, Folio 117, Sheet B420225.

Our Platform has been designed with the purpose of offering our products and services to the users of our Platform.

The relationship between the Platform and the User shall be governed by Law 34/2002, of 11 July, on Information Society Services and Electronic Commerce, by the Commercial Code, and other applicable Spanish legislation.

2. Operative

Personal information. Visiting the Platform does not imply that the User is obliged to provide any information about himself/herself. In the event that you provide any personal information, the data collected will be used for the purpose, in the manner and with the limitations and rights set forth in Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016, resulting in our Privacy Policy.

Registration. All users, whether registered or not, agree to accept these Terms and Conditions and to use the content in good faith.

In the registration process, we will request personal information from you in order to fulfil the purposes of managing your contractual relationship with us, as well as to respond to your requests and to keep you informed, including by electronic means, about our products and services.

Age. The User declares that he or she is of legal age (over 18 years of age) and has the necessary legal capacity to contract the products offered on the Platform, also stating that he or she accepts the link to this agreement and declares that he or she fully understands and accepts the present terms and conditions.

3. Contents Policy

Our Platform has been designed with the purpose of offering users of our Platform an assistance tool for the preparation of the exam organized by EBR "European Diploma in Radiology" (EDiR), as well as offering them our products and services.

At EBR we are committed to maintain the strictest confidentiality regarding the results of the tests that we make available to the user through the Platform, as well as not to index them in a way linked to the user for future data processings.

EBR ensures that the contents included in this Platform are up to date, even if the information may be inaccurate or imprecise in any respect.

The user undertakes to use the Platform in accordance with the law, these Terms and Conditions, the regulations and instructions brought to his/her attention, as well as morality, generally accepted good practices and public order. Likewise, it is expressly forbidden to use this Platform for purposes harmful to the property or interests of EBR or third parties, which in any way overload, damage, and/ or render useless or deteriorate the networks, servers, computer equipment, products and/or Platforms of EBR or third parties, or prevent their normal use.

EBR is not responsible for the transmission of information between users of this Platform. The content included in the Platform is provided only to consumers or end users. Any unauthorized commercial use of them, or their resale, are prohibited, except with the prior written permission of the owners of the Platform.

4. Special conditions of sale of EDiR trial exams and CORE

Inside the Platform EBR offers the User the possibility to acquire single units or packages of online products designed for the candidate's preparation of the European Diploma in Radiology (hereinafter referred to as "**Products**") which are defined below:

- Self-assessment tests: online trial exams of the European Diploma in Radiology
- Structured reports: "CORE" or online specific trial case studies.

The contractual relationship between EBR and the user upon such acquisition is regulated by this clause.

EBR is responsible for making the Products available and working on its Platform so that the user can acquire and use them.

Prices policy. Each Product offered through the Platform indicates the price of the service without any additional discount. The prices presented on the Platform include the applicable VAT and any other taxes that may apply. Eventually EBR will offer discounts and limited offers. The Platform are final prices and users will not have to pay any extra amount during their usage of the Product on the Platform.

Payment policy. The payment of any of the Products offered in the Platform will be managed through the gateways and means of payment of EBR.

In order to pay for the different products offered by EBR, the User will pay with a credit or debit card. The user will be required to provide data such as card number, expiry date and CVV to ensure payment security.

The information for the payment provided by the user is transferred through Secure Payment Gateways that ensure the security of your bank details. EBR does not store any of your bank details after the purchase of the corresponding product. Once the payment has been made, an email will be sent automatically to the email provided by the user with the confirmation of the order and the steps to follow to use the Product or Products you have acquired. EBR is not

responsible for any incidents that may occur during the payment process that are caused by the platform used to facilitate it.

Exchange and Returns Policy. Any User is entitled to withdraw the contract with EBR up to fourteen calendar days from the date of the purchase of the Product with the limitations stated herein. According to article 16.m of Directive (EU) 2011/83/EU, of 25 October 2011, *on consumer rights*, and any national transposition rule, the right the aforementioned right of withdrawal in 14 days is not granted to the User who has used the product or has begun to consume it.

A Product has not been used or its consumption has not begun when the User has not carried out a whole trial test, excluding from this calculation any free tests (DEMOS, challenges or open virtual exams) that eventually would be put at their disposal.

5. Minors under the age of 18

This Platform is not intended for children under the age of 18. Please activate parental control to prevent and control underage access to the Internet and inform minors about safety issues.

We encourage parents and guardians to regularly check and review their children's use of the Internet and e-mail. They should also ensure that they do not provide personal data without your permission and consent. When a minor under 14 years of age wishes to provide us with his or her personal data, he or she is required to provide us with the identification data and e-mail address of his or her parents or legal guardians in order to request their authorization, or to provide us with proof of their authorization with sufficient documentary input (e-mail attaching a duly signed authorization letter, providing a photocopy of their ID card or passport, or sending it by fax, which the Company would request prior to contracting the products).
